Some aspects of this course are being offered in real-time via scheduled meeting times. For those aspects you are required to be online at the same time.

To help ensure Zoom sessions are private, do not share the Zoom link or password with others, or on any social media platforms. This course has a registrar scheduled, asynchronous final exam. The writing time is 2 hours + 50% buffer time, but the exam can be written any time in a 24-hour window.

Asynchronous component - pre-recorded lectures posted in the first day of school.

Synchronous component - Q&A meetings of 20-50 minutes twice every week during the lecture time set by the registrar; these meetings are recorded and will be uploaded in D2L in the same day. So, you will have access to them even in case you missed the respective meeting. However, Q&A meeting attendance plays no role in your grade.

3. **Grading:**

In determining the overall grade in the course the following weights will be used:

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

This course will have a final exam that will be scheduled by the Registrar. [The Final Examination Schedule](#) will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 2 hours.

The final exam will be administered using an on-line platform. Per section [G.5](#) of the online Academic Calendar, timed final exams administered using an on-line platform, such as D2L, will be available on the platform. Due to the scheduling of the final exams, the additional time will be added to **the end** of the registrar scheduled **synchronous** exam to support students. This way, your exam schedule accurately reflects the **start time** of the exam for any **synchronous** exams. E.g. If a **synchronous** exam is designed for 2 hours and the final exam is scheduled from 9-11am in your student centre, the additional time will be added to the **end** time of the **synchronous** exam. This means that if the exam has a 1 hour buffer time, a synchronous exam would start at 9 am and finish at 12pm.

- the latest you should start an asynchronous exam would be 8 am in order to be able to submit the exam at 11am and have the full 3 hours.

4. Missed Components Of Term Work:

Course Outcomes:

- Implement the principles of science in the study of geological (and geophysical in subsidiary) sciences.
- Implement the principles of science in the study of the fossil record.
- Develop a defensible model of the Earth structure, composition, and its history through time.
- Develop a defensible model for the increase of complexity of the life forms in the Archean and Proterozoic.
- Develop a defensible model for environmental challenges in the evolution of earlier life forms on Earth
- Operate with basic concepts of geology, such as minerals and mineral groups, major rock types and rock cycle, and geological time.
- Develop a defensible model for the calculation of the age of the Earth.
