To account for any necessary transition to remote learning for the current semester, courses with in-person lectures, labs, or tutorials may be shifted to remote delivery for a certain period of time. In addition, adjustments may be made to the modality and format of assessments and deadlines, as well as to other course components and/or requirements, so that all coursework tasks are in line with the necessary and evolving health precautions for all involved (students and staff).

Online Delivery Details:

This course does not follow a scheduled meeting pattern.

This course has a registrar scheduled, asynchronous final exam. The writing time is 2 hours + 50% buffer time, but the exam can be written any time in a 24-hour window.

The course is delivered through pre-recorded lectures and textbook. It has three exams, two midterms and a final; all of them are online, in D2L. For each exam, there will be a window of 24 hours in which they must be completed. A buffer of 50% of the exam duration is added to compensate for the potential slow internet connection. All the regular exams consist of multiple choice questions; the deferrals can be in a different format.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

This course will have a Registrar Scheduled Final exam that will be delivered on-line. The Final Examination Schedule will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 2 hours.

Per section <u>G.5</u> of the online Academic Calendar, timed final exams administered using an on-line platform, such as D2L, will be available on the platform. Due to the scheduling of the final exams, the additional time will be added to **the end** of the registrar scheduled **synchronous** exam to support students. This way, your exam schedule accurately reflects the <u>start time</u> of the exam for any **synchronous** exams. E.g. If a **synchronous** exam is designed for 2 hours and the final exam is scheduled from 9-11am in your student centre, the additional time will be added to the **end** time of the **synchronous** exam. This means that if the exam has a 1 hour buffer time, a synchronous exam would start at 9 am and finish at 12pm.

 the latest you should start an asynchronous exam would be 8 am in order to be able to submit the exam at 11am and have the full 3 hours.

- Implement the principles of science in the study of geological (and geophysical in subsidiary) sciences.
- o Implement the principles of science in the study of the fossil record.
- Develop a defensible model of the Earth structure, composition, and its history through time.
- Develop a defensible model for the increase of complexity of the life forms in the Archean and Proterozoic.
- o Develop a defensible model for environmental challenges in the evolution of earlier life forms on Earth
- Operate with basic concepts of geology, such as minerals and mineral groups, major rock types and rock cycle, and geological time.
- o Develop a defensible model for the calculation of the age of the Earth.
