¹ Tutorials begin the week of January 23. Each of the eight (8) weekly tutorials must be submitted via D2L on Fridays by 5 PM, with the first due date occurring on Friday, January 27.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
