In Person Delivery Details:

Labs: There will be one (1) weekly lab period (about 3 hours). There will also be nine (9) lab assignments. The lab periods will provide an opportunity for students to work on the lab assignments and reports, collaborate with peers and discuss difficulties with TAs. There will be Lab midterm and Lab final exam in this course.

- Describe and interpret the textures and structures of igneous, metamorphic, and ore rocks in terms of geological processes.
- Describe, in a general sense, how and where the main types of igneous, metamorphic and ore rocks form.
- Write a complete mineralogical and textural description, with labelled sketch, of an igneous or metamorphic rock in hand sample or thin section.
- Use phase diagrams to interpret some features of igneous and metamorphic rocks.
- Operate a petrographic microscope in plane polarized and cross-polarized light.
