Course Outcomes:

- o Locate themselves on a topographic map, and recognize the expression of landscape features on a topographic map.
- o Operate a compass for successful navigation and orienteering.
- o Describe, sketch, and interpret a rock outcrop using geologic terminology.
- o Measure a stratigraphic section and construct a field log of the section, including description of rock units.
- o Measure the orientation of planar and linear geologic features.
- o Construct a geologic map that includes contacts, geologic symbols, and a legend.
- o Construct a geologic cross-section based on data collected in the field.
- o Recognize and describe a variety of surficial deposits and sedimentary, igneous, and metamorphic rocks in the field.
- o Visualize in 3-D the geologic structures revealed by the cross section(s) both (virtually) above and below ground.
