Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

Each piece of work submitted by the student will be assigned a percentage score. These percentage scores for various components will be combined with indicated weight to calculate an overall percentage score for the course.

This course will have a Registrar Scheduled Final exam that will be delivered in-person and on campus. <u>The Final Examination Schedule</u> will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 2 hours.

Students are required to obtain a minimum of 50% in the lecture tests (midterm and final exam combined) and a minimum of 50% in lab review summaries to pass the course.
