- Apply basic principles of structural geology, geophysics and petrology to explain processes and products at diverse tectonic settings
- Evaluate methods for characterizing structure and tectonics of a region
- Develop an understanding of processes that controls and drives tectonics and deformation
- Review the role of plate tectonics as a framework for explaining processes at Earth's surface and interior
- Read, discuss and summarize scholarly articles
- Conduct a literature research project
- Communicate science through writing and oral presentation
