#### **Course Outcomes:**

- Explain the principal mechanisms of lithospheric subsidence
- Communicate the linkage between the earth's geodynamic system and the origin and evolution of sedimentary basins
- Explain the main difference between basin types
- Explain the role played by physical parameters such as rheology, stress, strain, heat flow, mineral phases and radioactive heat generation in the origin and evolution of sedimentary basins
- Explain how interactions between processes occurring in the mantle, lithosphere, crust and surficial environments impact on the origin and evolution of sedimentary basins
- Assess the tectonic and climatic processes operating beyond the perimeter of a given basin based on the analysis of its sedimentary fill
- Explain how the depositional, subsidence history and thermal history of a sedimentary basin dictates the quality and state of its petroleum system
- List a large number of sedimentary basins in various parts of the world from different geodynamic settings and explain their origin and evolution
