Course Outcomes:

- Operate with basic concepts of paleontology: morphology and morphologic variability, geologic time, fossil distribution in space and time, and functional morphology.
- Operate with morphologic features to recognize patterns in stratigraphic distribution and evolutionary development of selected invertebrate fossil groups.
- Develop techniques to test the fossil record in terms of completeness and correlation potential.
- Develop a defensible model on the evolution, migration, and extinction of selected invertebrate fossil groups.
- Apply knowledge on living organisms to interpret fossils and their role in paleoecology and communities.
- $\circ~$ Apply morphologic data to discuss the species problem and describe species systematics.
