Course Objectives:

By the end of the course, students should be able to:

- Describe different types of natural hazards including how, why, and where they form.
- Understand the structure of the Earth, and how this influences natural hazards on Earth.
- Describe the timeline of events of several historical natural disasters as case studies.
- Understand the human influence on natural disasters, and understand how society deals with natural disasters in terms of forecasting, planning, dealing with the aftermath and mediating such events.

 $^{^{1}}$ 4 quizzes (administered through D2L) will occur throughout the term. Students will have 7 days to complete the quiz.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
