# 3. Grading:

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

## 4. Missed Components Of Term Work:

In the event that a student misses the midterm or any course work due to illness, supporting documentation, such as a medical note or a statutory declaration will be required (see <u>Section N.1</u>; for more information regarding the use of statuary declaration/medical notes, see <u>FAQ</u>). Similarly, students who are unable to submit laboratory reports or assignments on time because of similar circumstances will be required to submit the same type of documentation to the Lab Coordinator in order to be considered for a time extension. In the absence of adequate documentation, late work will be penalized with a 10% reduction in the grade, and an additional 10% for each day late beyond the submission deadline.

#### **Course Outcomes:**

- · Calculate the effective modulus for an isotropic heterogeneous medium, using appropriate, well-defined assumptions
- Apply their understanding of the empirically derived elastic constants, and their relationship to one another
- Communicate the basic relations between the acoustic, elastic, and microstructural parameters of a porous medium
- Develop reasonable, simplifying assumptions in their approach to modeling the subsurface
