#### **Course Outcomes:**

- Communicate the connection between rock (and sediment) physical properties and the geophysical measurements obtained during surveys
- Calculate the effective modulus for an isotropic heterogeneous medium, using appropriate, well-defined assumptions
- · Apply their understanding of the empirically derived elastic constants, and their relationship to one another
- Communicate the basic relations between the acoustic, elastic, and microstructural parameters of a porous medium
- Develop reasonable, simplifying assumptions in their approach to modeling the subsurface
- Estimate reasonable bounds for physical parameters, under surface/near-surface conditions
