### **Course Outcomes:**

- Explain the meanings of the various concepts and equations associated with seismic wave propagation theory and applications, e.g., Fourier transforms, stress, strain, equation of motion, wave equation, compressional and shear waves, ray parameter, reflection and transmission coefficients, surface waves, normal modes, waves in layered and heterogeneous media, waves in anisotropic media, seismic wave absorption.
- Perform basic mathematical calculations connected with seismic theory (e.g., algebra and calculus with complex numbers, single- and multi-variable calculus (derivatives, integrals), solving linear equations, basic matrix algebra, vector calculus).
- Calculate various quantities associated with seismic theory, such as Fourier transforms (frequency spectra) of seismic waveforms, seismic wave properties (wave speed, displacement direction, polarization, frequency, wavelength, amplitude), reflection and transmission coefficients, traveltimes of waves in various types of solid media, basic synthetic seismograms.
- Use the equations and formulas from seismic theory, and the relevant mathematics, to solve problems in seismic theory and derive other equations and formulas.
