# **Course Outcomes**

- 1. Apply concepts from petroleum geology (petroleum systems elements, source rock and reservoir characterization, mass and energy transport in sedimentary basins, fluid flow systematics, in-reservoir alteration processes) to design and implement the critical phases of an exploration, appraisal and production strategy for unconventional petroleum resources
- Apply critical thinking to technical and conceptual problems outside their experience and synthesise and integrate research and concepts in a specified problem area to provide an effective solution to an assigned problem
- 3. Describe the nature of technology and provide technical solutions involving multiple technologies, for geoscience related issues in the energy recovery and environment domain
- 4. Develop and implement reservoir characterisation strategies for unconventional petroleum reservoirs from examination of core and geochemical and geophysical logs and develop a defensible model of reservoir continuity based on features observed with these tools.
- 5. Communicate the development of reservoir characterization, recovery process design and carbon mitigation strategies for fossil fuels to a technical audience.
- 6. Write a scientific report at technical conference level on the analysis of scientific or engineering data.
